**SUPREME COURT OF NEW JERSEY
Attorney Ineligibility Order Pursuant to Rule 1:29-7(a)**

Pursuant to Rule 1:29-7, the *Attorney's Fund for Client Protection* (Fund) has reported to the Supreme Court the names of those attorneys who have neither made full payment to the Fund, the *Disciplinary Through Committee*, and the *Lawyer's Assistance Program* for the calendar year 2018, nor demonstrated that they are entitled to an exemption from making such payment.

And the Court having had the Treasurer send notice to each such attorney that unless all reporting and financial obligations were fully satisfied on or before April 27, 2018, his or her name would be published in the *New Jersey Law Journal* together with an Order of the Court declaring him or her ineligible to practice law.

And notwithstanding the fact that every reasonable effort has been made by the Treasurer to notify all attorneys of their obligations, unless exempt, to file an annual registration statement and make payment to the Fund, the attorneys whose names appear on the attached Ineligibility List here, as of the date of this Order, failed either to make full payment or to request and be granted an exemption.

IT IS ORDERED that pursuant to Rule 1:29-7(a), each attorney whose name appears on the attached Ineligibility List shall be ineligible to engage in the practice of law in New Jersey, effective June 4, 2018, and is to suffer:

ORDERED that each attorney whose name is included on the attached Ineligibility List shall remain ineligible to practice law in New Jersey until all fees due have been paid in full or until commitment to the military or other exemption from payment for each Ineligibility year has been satisfactorily demonstrated to the Treasurer, and is to suffer:

ORDERED that this Order and the attached list of attorneys are to be posted on the Judiciary's website and published in the *New Jersey Law Journal* no later than June 4, 2018, and that a copy of this Order be mailed to each attorney whose name appears on the attached list at the address shown therein, and it is further:

ORDERED that any amendments or corrections to this Order shall be printed and published as soon as may be practicable.
